

2024 NRT SPRING FARM FESTIVAL FOOD SERVICE VENDOR RULES & APPLICATION

For food trucks, food carts, and restaurant/ caterers

SATURDAY, May 4, 2024 - 10:00 A.M. – 2:00 P.M.

LOCATION: NRT's Sheep Pasture, 307 Main St., No. Easton, MA 02356

We welcome crafters and small businesses producing local goods to apply for booth space at the 2024 Spring Farm Festival. Emphasis as always is on local organizations and food. Food relating to local and healthy eating are encouraged.

Food Service Booth Fees: \$175.00 - Single (10'x10')/ \$250.00 - Double (10' x 20')

****All equipment/ trailers must fit inside the assigned space. Please indicate space required- single or double- on application form.***

No raffles, fundraisers, or collection of funds for a third-party organization are allowed at any space.

No balloons or food are allowed on site or as giveaway items at any time.

The NRT Spring Farm Festival is a rain or shine event. In the event that the festival is canceled by the NRT due to hazardous conditions, a refund or credit for participation in another event may be offered at the discretion of the NRT. Early closure of the event will not result in a refund to vendors. Vendors who apply for a space and then do not participate in the event for any reason will not be granted a refund or credit.

Any food service vendors interested in participating must include: Application, photos and/or a website link, and menu, with prices, of their goods for consideration to the festival. The festival committee will review applications upon receipt of all required information. Please be sure that your information/ website is representative of all items that will be sold. If you do not have a website or photos and would like to come in person to discuss your items, please submit contact information on your application, and you will be contacted for an appointment to bring your goods to NRT Spaces will not be held until payment is received within 7 days of approval. The NRT is not responsible for items (bowls, containers, equipment, etc.) left at NRT for consideration at any time. Items that are not picked up by April 26, 2024 will be considered property of the NRT and may be discarded at the discretion of the NRT. The NRT may restrict or accept individual menu items the vendor may offer as a term of acceptance into the event.

Setup time for the event is Saturday, May 4th from 7:30 am – 9:30 am only. ALL vendors must be in place and their vehicle removed from the fair area no later than 9:30 am. All vehicles and trailers will be removed from the fair area by 9:30 am and directed to on-site vendor parking. No cars/trailers will be allowed onto the fair area during the event unless approved prior to the event. All vendors are expected to be operational when the event opens at 10:00 am and have their booths attended for the duration of the event. Cars will be allowed back on the fair area at 2:15 pm, at the discretion of the NRT, to insure visitor safety. Pop up tents are allowed, but **must be securely fastened and weighted during the event**. Vendors who produce any waste at their booth must provide a trash receptacle and remove it at the end of the event. Vendors must supply their own tents, tables, food equipment, water source, wifi, and other equipment needed. Vehicles will not be allowed to re-enter the fair area during the event to deliver supplies. Electricity is not available at booths.

Applications must be received no later than April 12, 2024. Vendors will be considered as space allows, and submissions may be closed before that date if spaces are filled. Food service spaces are extremely limited. Applicants will be contacted after review.

It is the policy of the committee to select vendors on a year-to-year basis. We adhere to this policy in order to maintain the most diversified offerings and to continue the high standard of professionalism that we seek. In order to maintain a diverse selection of goods for visitors and enrich the overall event, the number of specific types of food offered may be limited at the discretion of the NRT.

Any vendor selling food products is responsible for complying with all state and local licensing regulations, permitting, and requirements. Food vendors will be asked to submit their paperwork, including insurance, prior to being allowed to sell products. Only commercial food vendors using approved production facilities will be considered for the event. Food service vendors must contact the Easton Board of Health and comply with all requirements for providing food services on May 4th. Certificates are required to be displayed during event operation and vendors may be denied the ability to operate, without refund, if the certificate cannot be provided at the event.

All booth assignments will be made by the NRT. All booths are outdoor spaces; wifi and electricity are not available at any booths.
