

**2024 NRT's Harvest & Craft Fair**  
**Crafter Vendor Information & Application**  
**Sunday, OCTOBER 6, 2024**

The NRT of Easton will be hosting the 2024 Harvest and Craft Fair from 10 am – 2 pm on Sunday, October 6, 2024 at the NRT's Sheep Pasture property in Easton. The NRT is planning for a vibrant and well-attended fair in 2024. Layout for the fair will accommodate any public health and safety concerns that may arise for both vendors and visitors at the event. Space between vendor booths will be increased and fair layout will work to minimize areas of congestion as visitors move throughout the fairgrounds. Please note that food sampling is not permitted at crafter booths in 2024 unless pre-approved by NRT. Crafters are responsible for all booth setup needs.

In 2024 individual crafters will communicate directly with NRT to request approval of their items for the event. NRT staff may request samples, photos, etc. in helping to determine eligibility. No new crafts are to be added to your display unless they have been pre-approved by the NRT. In order to be considered, items must be handmade and of good quality; resale items, direct/MLM sales, and wholesale of bulk items are not allowed at booths. Decisions of NRT staff regarding acceptance into the fair are final. Please contact the NRT at [info@nrtofeaston.org](mailto:info@nrtofeaston.org) with any questions.

**Applications will be reviewed beginning May 15, 2024 and will be reviewed on a rolling basis until spaces are filled. Do not submit payment with application. Crafters who are accepted will be notified and those who have received approval must submit payment within seven (7) days from notice of approval to hold their space. For any crafters who are approved after August 1st, payment is due at time of acceptance to reserve the space. After that time, booth spaces may be reassigned. Booth locations will not be guaranteed until your payment is received by the NRT. Late payments may result in loss of space. Refunds will not be issued for any vendors who choose not to attend the event for any reason.**

**Vendor information:**

In working with local health officials, additional changes may be made to the operations/layout if necessary at the time of the event. **Vendors will be required to comply with the most current local, state, and/or federal regulations at the time of the event in order to participate.** Vendors should plan to use the following standard safety procedures, including:

- Do not attend the event if you are feeling ill or have been in close contact with someone who has tested positive for Covid-19; masks are suggested for those that are unvaccinated or who are at high personal risk
- Have hand sanitizer available for both personal and customer use
- Sanitize customer spaces frequently throughout the day

The Harvest Fair runs from 10:00 a.m. – 2:00 p.m. NRT's Sheep Pasture is located at 307 Main Street in North Easton. **Crafters should enter at 261R Main Street, North Easton, MA 02356.** This entrance will be well marked. The gates open for crafters at 6:00 a.m. All vehicles must be removed from the fairgrounds by 9:30 a.m. Crafter parking will be on site at Sheep

Pasture, but will require walking to return to the vendor area. Volunteers will be on site to direct you to your booth location and the parking area. Please have your location number available when you arrive. Vehicles will not be allowed on the road when the fair ends until 2:30 p.m.

Crafters may also choose to set up on Saturday, October 5th between 9:00 a.m. and 2:00 p.m. only.. Volunteers will be available to help you locate your space. Set up closes promptly at 2:00 p.m. on Saturday and vehicles cannot be left on site. **There is no rain date for the Harvest Fair; vendors who choose not to attend for any reason will not receive a refund of fees. The NRT does not provide tents, tables, chairs, wifi, or electricity. Crafters must use a 10' x 10" canopy, this size will fit into the 12' x 12' marked assigned space. All canopies must be staked or securely weighted. Vendors may not place items outside of their marked booth space.**

**The Harvest and Craft Fair is a fundraiser which helps fund the NRT's operation of the Sheep Pasture property for the whole community. The NRT's Silent Auction is one of the favorite events that takes place at the Harvest Fair each year. Please consider a donation of your craft to the NRT's Silent Auction this year. Donated items will be viewed by hundreds of people and if provided, a business card will be placed next to your item. A volunteer will pick up your donation at your booth before the fair gates open on Sunday. The NRT appreciates your support.**
